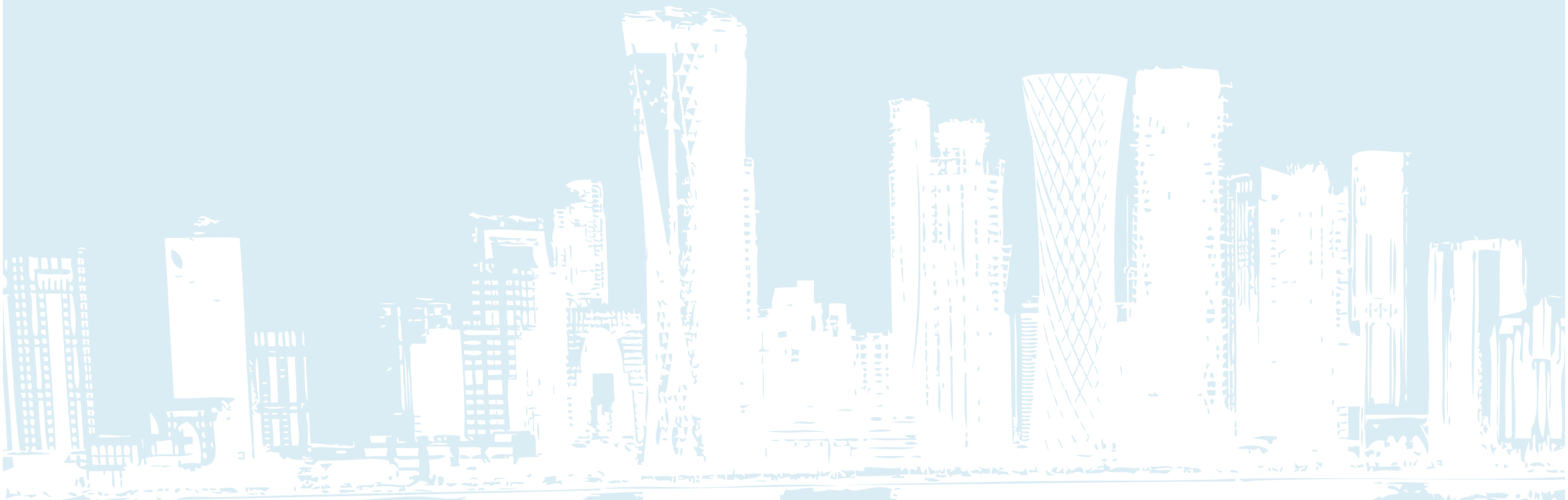

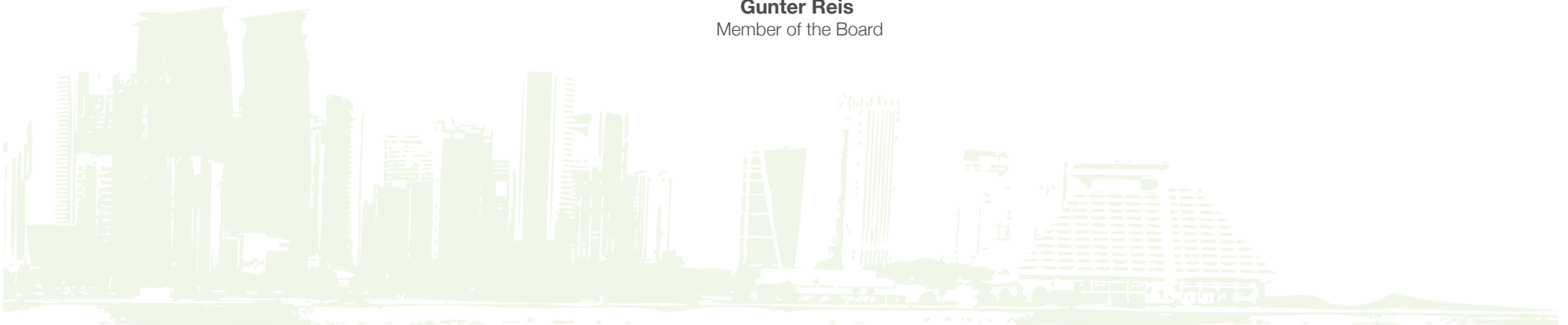

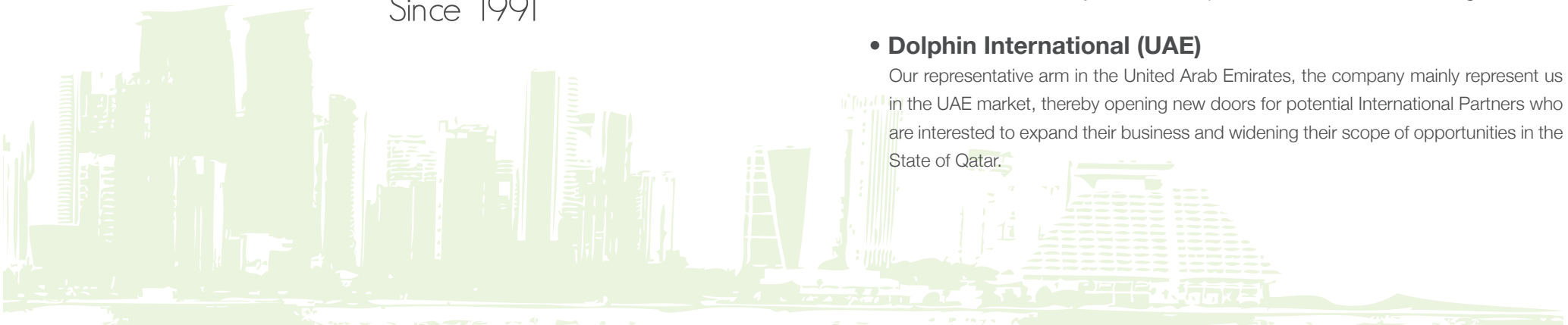

While Qatar has opened up its economy considerably in the last decade, the country's corporate law still stipulates that foreign entities may conduct business in Qatar only in partnership with a local individual or company. Dolphin Group specializes in creating affiliations with international firms operating in construction and related industries, thereby enabling its partners to operate in Qatar as well as being able to offer a comprehensive bouquet of services under one roof to the local market in conjunction with its several business partners.

Our international affiliates also benefit greatly from Dolphin's solid reputation in the Qatari market and direct links with decision makers and opinion leaders in the region's construction industry. In the end, it's a win-win proposition for everyone – our partners, local customers and our shareholders.

Once you're here, you'll need a little bit of help to find your bearings and complete some preliminary formalities such as visas and immigration procedures for your staff. Dolphin has a seasoned team of people to help you get through the process with a minimum of fuss

We'll also help you find a suitable office in a convenient location and introduce you to banks and consultants if you so desire. Dolphin also has its law firms on standby in case you need counsel.

As enablers of business, we are regularly called upon by our partners with a variety of sundry requests such as for transportation, catering, manpower supply, labor accommodation, security and maintenance to name a few. While we may not be able to attend to all requests ourselves, we can certainly point you in the right direction or introduce you to some of our contacts who might be of help.

Market Intelligence and Business Development

This is where Dolphin Group is in a class by itself. All leads will be investigated together by us and Dolphin will endeavor to secure an invitation for negotiations with the decision makers.
- 4.** Meanwhile, we will commence the registration procedures for our partnership to be represented as a legal entity recognized by the Ministry of Business and Trade. The appropriate company structure will be chosen after seeking legal advice and discussing it with you.
- 5.** Once the company is registered, Dolphin will hold your hand through the process of getting the regional office operational. This includes visa and immigration procedures, finding appropriate office space, legal assistance if required and even sourcing talent and manpower. If there's anything that we are in a position to help you with, you can be sure we'll do it.
- 6.** Even after you're fully operational we'll always be just a phone call away, should you require our assistance with anything at all. We pride ourselves in taking care of our partners and every request from you will be dealt with quickly and efficiently to the best of our ability.

Politics

Qatar is an emirate, ruled by the Emir HH Sheikh Hamad Bin Khalifa Al Thani who has been at the helm since 1995. Under his reign, Qatar has seen unprecedented growth and prosperity, and the country's leadership continues to show a keen eye for reforms and modernization. With high levels of satisfaction with the government and no other political parties or pressure groups operating in the country, the political climate of Qatar can be described as highly stable.

Landmark reforms in recent years include a new constitution approved by popular referendum, preparations for a mostly elected national legislature and moves to hold public officials to higher standards of performance and accountability, greater transparency and a consistent process of social liberalization.

Although Qatar is an Islamic state, practice of other religions is permitted. The first Christian Church in the country was completed in 2007 followed by another in 2009, standing testament to the tolerant policies of the government.

Economy

Qatar has experienced rapid economic growth over the last several years on the back of high oil prices, and in 2008 posted its eighth consecutive budget surplus. Economic policy is focused on developing Qatar's non-associated natural gas reserves and increasing private and foreign investment in non-energy sectors, but oil and gas still account for more than 50% of GDP, roughly 85% of export earnings and 70% of government revenues.

The oil and gas revenues have driven Qatar's per-capita income to one of the highest in the world, and made the economy one of the world's fastest growing. Even in the face of the recent global slowdown, Qatar's economy remains robust thanks to many years of budget surpluses and the continued demand for natural gas around the world, albeit at lower prices.

Real Estate & Construction

As Qatar pumps its hydrocarbon income into infrastructure and real estate, the construction sector continues to grow at an impressive clip. The skyline of Doha city has been completely transformed in the last five years and construction continues unabated, particularly in the business district of the city. Further out of town, brand new cities are being developed to house the growing population and huge industrial and energy projects are beginning to become operational with many more on the way.

The sector is gaining increased importance in the economy, with one third of Qatar's workforce being involved in the construction & real estate sectors directly or indirectly. The sector's contribution to the GDP in 2006 was 5.6%, marking an impressive growth of 17.7% for the sector over the previous year. Growth figures for 2007 and 2008 also remained in the double digits.





Banking & Capital Markets

With a rapidly expanding economy and population, it comes as no surprise that Qatar's banking sector is growing proportionately to keep pace. In spite of the highly competitive environment, the net profits of Qatar's eight listed banks rose 56% in 2007. Both conventional and Islamic banking services are widely available in Qatar, with several more banking institutions poised to enter the commercial and retail banking markets soon. In 2005 the Qatar Financial Center (QFC) was established, which has since attracted many of the world's leading financial institutions to launch operations in the country. The QFC also regulates the operations of the Doha Securities Market (DSM), which has become one of the fastest growing bourses in the region. Qatar has won international acclaim for its fast-improving regulatory climate, which includes an ongoing process of fine tuning the regulatory regime.

Health & Education

The government is taking proactive steps to ensure that the country's healthcare and education facilities expand in step with Qatar's growing population. In 2008/9, the government granted US\$ 2.5 billion to the health sector to provide free healthcare for citizens and heavily subsidized treatment for expatriate residents. Per capita health expenditure is one of the highest in the region at US\$ 1,200.

As far as education goes, the country is in the midst of a transformation that is quickly making Qatar a hub of learning in the region. The number of independent schools in the country has mushroomed in recent years and the newly constructed sprawling Education City campus has seen the arrival of six prestigious US universities, which together take in over a thousand students each year.



Sports

Whether it is football, tennis, powerboats or motorsports, Qatar has succeeded in attracting the best in the sporting world by establishing itself as a global sporting destination. The Qatar Olympic Committee (QOC) is in charge of sporting development in the country with the dual mandate of promoting Qatar as a destination for regional and global sporting events as well as encouraging citizens of Qatar to take up sports and making adequate facilities available.

Qatar's moment of glory in the sporting world undoubtedly came in 2006, when it played host to the 15th Asian games. Qatar also hosts such prestigious annual events as the MotoGP, Class 1 Powerboat racing and prestigious tennis and golf tournaments.

Meetings, Incentives, Conferences & Exhibitions (MICE)

Qatar's strong focus on developing the premium niche of business tourism in the country bodes well for the Meetings, Incentives, Conferences & Exhibitions (MICE) industry. Doha boasts a state of the art exhibition center with an area of 15,000 sq m, which hosts a growing list of events and exhibitions every year. Plans are also underway to develop a new exhibition center that will be triple the size of the current facility, thereby attracting some of the largest exhibitions in this part of the world to Qatar.
